 - 4.2. California Highway Patrol (CHP)
 - 4.2.1. New to the area, here to introduce and discuss concerns.
 - 4.2.2. Public Concerns:
 - 4.2.2.1. Riverside CHP Call station: 951-637-8000
 - 4.2.2.2. Light delay is too short for Harvill Rd and 215 entrance, drivers are running the red light.
 - 4.2.2.3. Lots of drunks in Mead Valley, concerned with shops selling alcohol to drunks. CHP response: DUIs are a frequent issue. CHP is placing sobriety checkpoints.

- 4.2.2.4. Concern with Off-road Vehicles. CHP response: aware of the issue and continuing to gather data. Data is confidential.
- 4.2.2.5. Will the sheriff's dept get off-road vehicles? Sheriff's response: a team is available, but the team travels throughout the county.
- 4.2.2.6. Kudos from a new resident, CHP is doing great. Concern with commercial drivers obstructing streets.
- 4.2.2.7. County Ordinance to not allow commercial vehicles to park in residential areas. CHP will follow up.
- 4.2.2.8. Concern with commercial vehicles from warehouses parking on Harvill Rd. HWY Response: Check with County Transportation

 - 4.3.1. 384 calls for service, 116 medical emergencies, 24 traffic collisions, 4 vegetation fires 1 vehicle fire, 6 residential structural fires, 20 false unintentional alarms, 6 public services assist (blackouts, flooding)
 - 4.3.2. Free permits are accessible for some burns and can be obtained from the fire station. Process: Inspect items to burn and the container. Must be in an approved container that retains embers, and a water source must be close by. Permits can be written for several days. Delay for permit and inspection varies. Containers are available at hardware stores.
